Orthodox Theology and the Philosophy of Technology



On the occasion of the centenary of the founding of the journal *Θεολογία*, the Holy Synod of the Church of Greece decided to honor this important anniversary by organizing two international scientific conferences. The first, on the theme: “Orthodox Theology *in via* in the ‘Dematerialized Reality’ of Late Modernity,” was held in Athens in October 2023, with the participation of distinguished theologians alongside experts from diverse scholarly disciplines from the Orthodox world and beyond. It was a pioneering and innovative initiative, supported on a pan-Orthodox level and with inter-Christian outreach, since for the first time a Church organized a meeting on such a subject within the Christian world. Furthermore, it highlighted the crucial role of the Church of Greece not only in the theological approach to a contemporary and timely issue, but also in the formation of a broader interdisciplinary dialogue related to it.

The second International Anniversary Conference, to be held in Thessaloniki (2025), bears the general title: “Orthodox Theology and the ‘Ontology’ of Technology: Anthropological, Political, Economic, Social, and Cultural Consequences.” Its first thematic area concerns the history of the journal *Θεολογία* from its founding until today and the evaluation of its overall contribution to the cultivation of Orthodox theology, through a wide field of theological disciplines (such as Church History, Dogmatics, Patristics, Hagiography, etc.), as well as related areas of scientific research (e.g. philology, philosophy, history, sociology, psychology, etc.). The second thematic area concerns the discourse of the Orthodox Church and theology vis-à-vis the ontology and, more broadly, the philosophy of technology. That is, how the new digital reality and its applications –regardless of good or bad use– affect the nature, essence, and mission of the Church and its theology, and how they impact fields such as liturgical life, anthropology, pastoral care, mission, and other dimensions of human existence. In other words, it is a kind of “extension” of the proceedings of the first conference and a further deepening of the relevant reflection. To the best of our knowledge, this is probably the first conference of its kind on the philosophy of technology.

This deepening concerns mainly the issue of the good or bad use of technology and the notion of its “neutrality.” As philosophers, sociologists, and scholars have argued since the early 20th century, the perception that technology is inherently neutral is an ideological construction which shifts all problems –real or anticipated– onto the field of its good or bad use. The



typical argument of this approach is that a knife can be used to cut bread or to kill, therefore its usefulness or harm depends on its use, not on its nature or essence. Yet it is overlooked that a knife is from the outset designed to cut. And even if one concedes that the question of good or bad use applies to a knife or other objects, what, for example, can be said about the atomic bomb, or about weapons such as the Kalashnikov or the Uzi?

Already from the 19th century, and especially from the early 20th century, writers and philosophers (e.g. S. Butler, E. Carpenter, L. Tolstoy, B. Russell, etc.) pointed out that the problem of technology does not lie in its good or bad use, but in its very essence, which is not merely technical but rather a specific worldview and philosophy. Technology, in other words, is based on, arises from, and reproduces a particular stance towards the world/nature, the human being, and God. Moreover, insofar as it embodies a purpose, one cannot speak of neutrality. It is no coincidence that this insight was articulated after the Industrial Revolution, since at that time a real rupture occurred: the introduction of the machine, which radically altered the relation of human beings to the notion of tools, manual labor, time, distance, etc.

Nevertheless, the position of neutrality and of the good or bad use of technology was not abandoned; it was promoted even more forcefully after the dropping of the nuclear bomb (1945) and continues to be maintained even today. However, from the mid-20th century onwards, after the painful experience of the Second World War, many philosophers and researchers questioned the neutrality of technology. They emphasized that technology is not simply a collection of tools, but determines our relationship with everything, pushing us toward a utilitarian and mechanistic understanding of life (Heidegger, Kyriazopoulos), restructuring human society along mechanistic and hierarchical lines (Mumford), “dehumanizing” us by rendering us incapable of moral reflection (Anders), and serving structures of power and domination which create artificial needs and strip individuals of their autonomy (Illich).

Technology, therefore, is not merely a tool, a means that can be used for good or evil. Regardless of its use, it embodies a specific essence (what philosophers call a “technical spirit”), that is, a particular perception of reality, of the human being, of nature, and of God. This perception gives priority to control, efficiency, and functional rationality. The modern technological paradigm, rooted in the Enlightenment and developed with industrialization, perceives the world as an object to be conquered and managed, as a

warehouse of resources awaiting human exploitation. In the pre-industrial era, nature was regarded as having inherent value and sacredness—as the dwelling place of the divine (in pagan societies) or as a manifestation of God's love. For technology, however, nature is nothing more than raw material for human use.



The technical spirit also redefines what it means to be human. The rise of mechanization and digitization has turned the human being into a simple node within vast productive systems, a functional unit of a wider technological mechanism. This is evident in various sectors: in the economy, where human labor is increasingly optimized, automated, and quantified, with success measured in terms of productivity rather than purpose or fulfillment; in social life, where digital technologies shape our interactions, replacing direct face-to-face relationships with algorithm-mediated ones; even in medicine, where life tends to lose its sacredness, being approached through statistical data and measurable risks. Thus, technology reshapes human existence itself, not only our perception of it, forcing us to conform to the logic of efficiency and control.

Perhaps the most important aspect of the technological worldview is its relation to the concept of God. Traditional views of God emphasized mystery, metaphysics, and the limits of human knowledge and finitude. Technology, however, in its essence concerns domination and absolute control. As it evolves, it fosters the conviction that all aspects of existence can ultimately be understood, controlled, and redesigned.

In pre-modern societies, religious and metaphysical traditions set boundaries to human activity, recognizing that certain aspects of reality were inaccessible to the human mind and action. Technology, however, inspires the opposite tendency: an endless expansion, where limits are considered challenges to be overcome, rather than intrinsic features of the human condition. This is most evident in transhumanism, artificial intelligence, and genetic engineering, which aim at surpassing human limitations, attempting to abolish every boundary and distinction – even the distinction between the created and the Uncreated.

All these changes that the technical spirit has introduced into traditional conceptions of the world, humanity, and God are transmitted and reproduced through the use of technological applications, *regardless of whether that use is good or bad*. In other words, even if we could ensure that technology



would only be used for good purposes, *we would still, even unconsciously, be influenced by its technological worldview*. On the other hand, how feasible would it be to ensure exclusively “good use,” living in a fallen world where no one is without sin?

This concern becomes even more pressing today, with the development of digital technology, which completely overturns our earlier certainties, creating the illusion that the limits of human potential have been transcended. Automations of every kind, Artificial Intelligence, and even the advertised “resurrection of the dead” (deathbots, griefbots, etc.) are generating a novel world, the evolution of which is not easy to predict.

The problem ultimately is not only *what we do with technology*, but *what technology does to us* – even when we are not aware of it. And since we cannot reverse technological development, nor live outside of it (unless, as Hannah Arendt suggests, we return to the culture of tools), it is necessary to examine critically the essence of technology –its “ontology”– going *beyond the dichotomy of good or bad use*.

It could be said that the view of neutrality and of good/bad use represents a compromise between technophobia and technolatry. The purpose of the Conference, however, is not to be trapped within this dipole, for the role of Orthodox Church and Theology is to image the Eschaton within History and to remind that human beings cannot derive their identities from created certainties or from the absolutization of History – whether they are believers or not. For this to happen, however, the Church and its Theology must not lose the perception of personhood, relationship, and embodied communion-community.

Very Rev. Mr. Aetios (Nikiforos). Grand Ecclesiarch, Director of the Patriarchal Private Office. Holder of an LL.B. from the School of Law of the Aristotle University of Thessaloniki and of an M.Div. from St. Vladimir's Orthodox Theological Seminary in New York. He further pursued postgraduate studies in Public Law and Political Science at the School of Law of the Aristotle University of Thessaloniki (M.Phil.), with specialization in Constitutional Law, and in Legal Theory at the School of Law of New York University (LL.M.), with specialization in Constitutional History. He was awarded a Ph.D. in Canon Law by the School of Law of Cardiff University, United Kingdom. He entered the ranks of the holy clergy in 2019. He was ordained deacon on 17 March 2009 and presbyter on 3 November of the same year in the Patriarchal Cathedral of St. George at the Phanar by His All-Holiness Ecumenical Patriarch Bartholomew, who also conferred upon him the office of Grand Ecclesiarch of the Great Church of Christ. On 17 March 2021, he was appointed Director of the Patriarchal Private Office. He is a member of the Synodal Committee on Inter-Orthodox Affairs and of other ad hoc Committees, as well as a Secretary Member of the Synodal Committee on Canonical Matters.

Georgios Io. Androutsopoulos. Attorney-at-law before the Supreme Court of Greece, Associate Professor of Ecclesiastical Law at the Faculty of Law of the National and Kapodistrian University of Athens (NKUA), and Director of the Laboratory for Ecclesiastical Law and State–Church Relations at the same Faculty. He was born in Patras and studied Law at NKUA, where he also completed his postgraduate and doctoral studies specializing in Ecclesiastical Law. He served as a Postgraduate Research Fellow in the Department of History and Theory of Law (2001) and received scholarships from the State Scholarships Foundation (IKY) (2001-2002 and 2004-2006). He was also a Scientific Associate at the General Secretariat for Religious Affairs of the Ministry of National Education and Religious Affairs (2003-2004). He is editor of the biannual journal *Nomocanonical Review* (Νομοκανονικά) and a founding member of the Hellenic Society for Ecclesiastical and Canon Law. He has been a full member of the Committee on Dogmatic and Canonical Issues of the Holy Synod of the Church of Greece (since 2020), and of the Hellenic Association of Public Law Scholars (since 2018). He has authored monographs, numerous scholarly studies, and a significant number of articles and commentaries in newspapers and academic journals on topics related to Ecclesiastical Law. He has also been a speaker at numerous academic conferences and symposia in Greece and abroad.

H.E. Bartholomaios, Metropolitan of Polyani & Kilkis. Born Dimitrios Antoniou-Triantafyllidis in Thessaloniki in 1969. He studied Theology in Athens and was ordained Deacon in 1992 and Presbyter in 1994. For many

years he served at the Church of the Transfiguration of the Savior (Plaka, Athens), developing rich pastoral and social work, while also contributing to the administration of the Church of Greece (Certification Office, Synodal Committees, organization of conferences and events on the Greek Revolution of 1821). On 8 October 2021 he was elected Metropolitan of Polyani and Kilkis, ordained on 16 October and enthroned on 26 November of the same year.



Stylianos D. Charalambidis. Assistant Professor of the Ecumenical Movement and Inter-Orthodox Relations at the Department of Social Theology and Christian Culture, Aristotle University of Thessaloniki. He was born in Thessaloniki in 1979. He holds degrees from both the Faculty of Theology and the Faculty of Law of the AUTH, as well as a Master's degree and a PhD (with distinction, cum laude) in the field of the Ecumenical Movement. Between 2017 and 2020 he carried out Postdoctoral Research. His research interests include the history of the Ecumenical Movement, the organization, structure, and functioning of inter-Christian organizations, bilateral theological dialogues, inter-Orthodox relations, inter-Orthodox and inter-Christian cooperation in the diaspora, the Holy and Great Council of the Orthodox Church, and the geopolitics of contemporary Orthodoxy. He participates in the Ecumenical Movement both at the central level (World Council of Churches) and the regional level (Conference of European Churches). He is the author of four monographs, while his studies have been published in Greek and international academic journals and collective volumes.

H.E. Chrysostomos (Sabbatos), Metropolitan of Messinia. Professor at the National and Kapodistrian University of Athens (NKUA). He was born in Peristeri, Attica, in 1961. He studied at the Higher Ecclesiastical School of Athens and at the Faculty of Theology of the NKUA. In 1988 he was ordained Deacon and, with a scholarship from the Roman Catholic Church, pursued postgraduate studies in Rome (Pontificio Istituto Orientale, Pontificio Università Gregoriana), while also attending courses in Greek Palaeography and Diplomats at the Scuola di Paleografia Diplomatica e Archivistica of the Vatican State. He continued doctoral studies at the University of Strasbourg (1989-1991) and in 1990 was ordained Presbyter, receiving the office of Archimandrite. In 1999 he was elected Lecturer at the Department of Theology of NKUA and in 2007 Professor. The same year he was elected Metropolitan of Messinia. He also served as Chair of the Department of Theology at NKUA (2013-2015). He has served as Secretary and member of the Synodal Committees of the Holy Synod of the Church of Greece (on Dogmatic and Canonical Issues, Inter-Orthodox and Inter-Christian Relations, and European Affairs). He is a member of the Boards of the Inter-Orthodox Centre and the Apostoliki Diakonia of the Church of Greece. He participates in the official Delegation of the Church of Greece in the



Theological Dialogue between the Orthodox and the Roman Catholic Church and in the World Council of Churches (Commission on Faith and Order). He has represented both the Church of Greece and the Patriarchate of Alexandria at numerous Inter-Orthodox and Inter-Christian conferences.

H.E. Chrysostomos, Metropolitan of Mani. His secular name is Christos Kon. Papathanasiou. He was born in Athens in 1950. He studied at the Faculty of Law and the Faculty of Theology of the University of Athens and pursued further studies at the Universities of Paris (Sorbonne) and Geneva. He holds a PhD in Canon Law from the Faculty of Theology and a PhD in Ecclesiastical Law from the Faculty of Law of the University of Athens. On 20 February 2000 he was ordained Deacon, and on 28 May 2000 Presbyter, by the late Archbishop Christodoulos of Athens, and was given the rank of Archimandrite. He served as Preacher of the Archdiocese of Athens, particularly at the Cathedral of Athens for fifteen years. He was Director of the Private Office of His Beatitude Archbishop Ieronymos II of Athens and All Greece, while also serving as priest at the Arsakeia Schools (Psychiko). He has authored books and studies and participated in numerous conferences in Greece and abroad. On 7 February 2018 he was elected Metropolitan of Mani and was consecrated on 10 February of the same year at the Metropolitan Cathedral of Athens.

Protopresbyter Dr Doru Costache. A Romanian Orthodox clergyman living in Australia and an Associate Professor of Theology at the Sydney College of Divinity (SCD). He was recently appointed Academic Dean of Nisibis Assyrian Theological College, an SCD member institution. He is also Research Director at ISCAST (Melbourne), coediting the interdisciplinary journal *Christian Perspectives on Science and Technology*. He was the Selby Old Fellow in the Religious History of the Orthodox Christian Faith at the University of Sydney Library and an Honorary Research Associate in Studies in Religion, the University of Sydney's School of Humanities. He participated in the project "Science and Orthodoxy around the World", of the Institute of Historical Research at the National Hellenic Research Foundation (Athens). Recently, he guest edited a special issue of *De Medio Aevo* (Complutensian University of Madrid), on the history of Byzantine science and technology. He authored *Nature Contemplation in Clement of Alexandria: Elements of the Method* (2025) and *Humankind and the Cosmos: Early Christian Representations* (2021). He coauthored *A New Copernican Turn: Contemporary Cosmology, the Self, and Orthodox Science-Engaged Theology* (with Geraint F. Lewis, 2024) and *Dreams, Virtue and Divine Knowledge in Early Christian Egypt* (with Bronwen Neil and Kevin Wagner, 2019).

Achilleas Dellopoulos. Postdoctoral Researcher at the Department of Theology, National and Kapodistrian University of Athens (NKUA). He was born in



Kozani in 1977. He studied Theology at the Aristotle University of Thessaloniki (AUTH) and at Ludwig Maximilian University of Munich. In 2014, he was awarded a PhD by the Department of Theology, AUTH. He is the author of six books. He has a command of Italian, German, French, and English, and has published a series of articles in all four languages. He has delivered lectures at the Department of Theology of the Faculty of Theology, AUTH, and has participated in international conferences both in Greece and abroad. He is a member of the International Association of Orthodox Dogmatic Theologians (IAODT) and of the DAAD Alumni Association (German Academic Exchange Service).

Nikos Erinakis. Assistant Professor of Social and Political Philosophy and Philosophy of Culture at the University of Crete. He also teaches at the University of Athens, the Athens School of Fine Arts, and the Hellenic Open University. He holds a PhD in Philosophy from the University of London, where he began his dissertation, which he continued and completed as a recognised research student at the University of Oxford with a full scholarship from the State Scholarships Foundation (IKY). He studied Economics (Athens University of Economics and Business), Philosophy and Comparative Literature (University of Warwick), and Philosophy of the Social Sciences (LSE), and is a graduate of Athens College. He has served as a member of the Board of the Athens and Epidauros Festival and as Director of Strategic Development of the Corfu International Festival, and is currently a board member of the Greek Youth Symphony Orchestra. His first book of philosophy, *Authenticity and Autonomy: from Creativity to Freedom* (2020), was awarded the Prize of the Academy of Athens. Three collective volumes of philosophical essays have been published under his editorship, as well as three poetry books and two translations of modernist European poets. His essays, articles, and poems have appeared in international journals, collective volumes, anthologies, and peer-reviewed conference proceedings. At present, he teaches and writes extensively on issues related to the Philosophy of Artificial Intelligence and Digitality.

Fr François Euvé. A catholic priest, Jesuit, Professor of systematic theology at Facultés Loyola Paris. He is currently editor in chief of the cultural journal *Études*. His first formation is in physics (Ecole normale supérieure de Cachan). He defended his doctoral thesis in theology at the Centre Sèvres in Paris (presently: Facultés Loyola Paris) in 2000. He is member of the redaction committee of the journal *Recherches de Science religieuse*. He is Fellow of the International Society for the Study of Science and Religion. Among his publications: *La science, l'épreuve de Dieu?* (2022); *Théologie de l'écologie. Une création à partager* (2021); *Dialogue sur l'histoire, la religion et les sciences* (with Michel Blay) (2019); *Pour une spiritualité du cosmos. Découvrir Teilhard de Chardin* (2015), translated into Corean and Spanish; *Mathématiques, astronomie, biologie et soin*



des âmes. Les jésuites et les sciences (2012); *Darwin et le christianisme. Vrais et faux débats* (2009), translated into Greek, Polish and Russian; *Science, foi, sagesse* (2004), translated into Portuguese; *Penser la création comme jeu* (2000), translated into Portuguese.

Christodoulos St. Flordellis. Professor Emeritus at the School of Medicine of the University of Patras. Graduate of the School of Medicine, National and Kapodistrian University of Athens (1972) and of the Department of Biology, NKUA. (1977). Holder of a PhD from the Aristotle University of Thessaloniki (Supervisor: Prof. Antonis Trakatellis, 1980). Board-certified in Internal Medicine (1980, 2nd Propaedeutic Clinic, AUTH, Director: Prof. P. Metaxas). Served at Mount Sinai School of Medicine, New York, USA (1980-1983) and at the National Institutes of Health (NIH), MD, USA (1983-1985). Lecturer in Pharmacology, Harvard Medical School (1985-1988), Research Assistant Professor, Boston University School of Medicine, USA (1990-1994), and Professeur Associé at Université Paris VI, St. Antoine, Paris, France (1993-1995). For 20 years Professor and for 15 years also Director of the Laboratory of Pharmacology, School of Medicine, University of Patras. Furthermore, served as Deputy Chair and Chair of the Department of Medicine, University of Patras. Has held positions of administrative responsibility for pharmaceuticals in National and European Organizations. His broader academic interests focus on the fields of the theory of Biology-Medicine, Philosophy, and Psychoanalytic theory.

H.E. Gabriel, Metropolitan of Nea Ionia, Philadelphia, Irakleio and Chalkidona. His secular name is Georgios Papanikolaou. He was born in Athens in 1976. He graduated from the Faculty of Theology of the National and Kapodistrian University of Athens, obtained a Master's degree in Orthodox Theology from the University of Fribourg, and holds doctorates in Theology (NKUA) and in Political Science (WTC, Geneva). He was ordained Deacon in 1996 and Presbyter in 2002, receiving the office of Archimandrite. He served as parish priest of St Marina in Thiseio, Chancellor (Protosyngellos) of the Archdiocese of Athens (2009-2011), and Chief Secretary of the Holy Synod (2011-2014). He also collaborated with the Holy Synod on inter-Christian and European affairs, and with the European Commission in the office of the Greek Commissioner for Social Affairs. He has represented the Church of Greece at numerous international conferences, the World Council of Churches, and inter-Christian dialogues. He has also taught at Athens College and has broad pastoral and educational experience. On 10 October 2014 he was elected Metropolitan of Nea Ionia, Philadelphia, Irakleio and Chalkidona, and was enthroned on 1 November of the same year.



Archim. Aristarchos Grekas. Clergyman of the Holy Archdiocese of Athens and Associate Professor at the Department of Theology, School of Theology, National and Kapodistrian University of Athens (NKUA). He holds degrees from the Arsakeion Pedagogical Academy of Patras and the Department of Primary Education of NKUA. From the Department of Theology of the Aristotle University of Thessaloniki (AUTH) he graduated with distinction, receiving a Bachelor's degree, a Master's degree (MSc), and a Doctorate. In the United Kingdom he earned a Master's degree (MSc) in International Relations and Governance from Durham University, and successfully completed programs at Oxford University and Cambridge University. In the United States he completed a postgraduate program at Georgetown University – School of Foreign Service, as well as two programs at Harvard University – Kennedy School. He lived for nearly twenty years at Mount Athos. From 2015 to 2019 he taught at the Higher Ecclesiastical Academy of Athens, serving on secondment and as Special Teaching Staff (EDIP). Since May 2019 he has been a Faculty Member at the Department of Theology, School of Theology, NKUA, specializing in Ecclesiastical Literature and Theology. He is Director of the Laboratory “Church and Culture” of the Department of Theology at NKUA. He also teaches in schools of the Security Forces and the Armed Forces. He has published 14 books and numerous articles in both Greek and English. He has organized and participated as a speaker in international conferences and symposia. He has received scholarships from the State Scholarships Foundation (IKY – Erasmus) and from Georgetown University (USA).

H.E. Ierotheos (Vlachos), Metropolitan of Nafpaktos and Agios Vlassios. He studied at the Theological School of the Aristotle University of Thessaloniki. He received an award from the Academy of Athens in 1996 for his book *The Person in the Orthodox Tradition*. He has written 123 books with theological, ecclesiological, sociological, and historical content, and from these 118 translations have been made into 27 languages. He taught as a Professor at the Balamand Theological School “St John of Damascus” of the Patriarchate of Antioch. He is a Professor on the Doctoral Program of the Antiochian House of Studies in the USA. He was awarded an Honorary Doctorate by the Department of Social Theology of the Theological School of the National and Kapodistrian University of Athens (2008), and by the Department of Medicine of the School of Health Sciences of the University of Ioannina (2016).

Fr Răsvan Andrei Ionescu. Parish priest of the Romanian Orthodox parish “Sfânta Parascheva – Sfânta Genoveva” (Saint Sulpice Church, Paris), permanent counselor in the Romanian Orthodox Metropolis for Western and Southern Eu-



rope (Department of “Theology and Science”), and Vice-Dean of the “Dumitru Stăniloae” Orthodox Center for Studies and Research (CDS) in Paris. He studied Electrical and Medical Engineering in Bucharest, where he received his PhD in Biomedical Engineering (Université de Technologie de Compiègne – Polytechnic University of Bucharest, 2002). He also holds a Bachelor’s degree in Pastoral Theology (Faculty of Orthodox Theology, Bucharest), an MA in Theology, and a PhD in Orthodox Theology (Institute of Orthodox Theology “Saint Serge,” Paris), with a thesis on the relationship between Orthodox Theology and Science. His publications include: *Orthodox Theology and Science* (2005, republ. 2006), *Orthodox Theology and Science: Conflict, Indifference, Integration or Dialogue* (2015), *Patristic Landmarks in the Dialogue between Theology and Science* (2009), *Father Proclus as I knew him*, and the *Dictionary of Orthodox Theology and Science* (2016, with Adrian Lemeni). He also co-authored the two-volume *Orthodox Apologetics*, an official textbook for Orthodox Faculties in Romania, and contributed to the *Dictionary of Orthodox Theology* (Romanian Patriarchate, 2019).

Fr Vasileios I. Kalliakmanis. Professor Emeritus of Aristotle University of Thessaloniki (AUTH), Protopresbyter of the Ecumenical Patriarchate. He studied in Athens, Thessaloniki, Geneva, and Fribourg (Switzerland). He served as a faculty member in the Department of Theology of AUTH, in the field of Ethics and Sociology, where he taught Ethics, Bioethics, Pastoral Theology, and Counseling. He has been appointed a member of three Synodal Committees of the Church of Greece: on Bioethics, on Liturgical Renewal, and on Worship and Pastoral Work. He is married, with four children. He has also taught at the Faculty of Theology of the University of Belgrade, and has lectured widely on theological, liturgical, medical, and historical topics in Greece, Russia, Bulgaria, Cyprus, and Constantinople. He has published over 70 articles in journals, collected volumes, and conference proceedings, as well as nine books. Several of his articles have been published on the website *Pemptousia* and translated into English. His book *Theological Currents in the Ottoman Period* has been translated and published in Serbian, while his book *Marriage and Family Life* has been translated and published in Russian.

Archim. Isidoros Ch. Katsos. Assistant Professor of Theological Epistemology and Philosophy at the Department of Theology, School of Theology, National and Kapodistrian University of Athens (NKUA). He holds a PhD in Law (Freie Universität Berlin) and a PhD in Philosophy and Theology (University of Cambridge). He has been a Postdoctoral Fellow of the British Academy and has taught theology and philosophy at the Universities of Oxford and Cambridge, as well as at the Hebrew University of Jerusalem. He is a Fellow of the Royal Historical Society, the Center for the Study of Law and Religion at Emory University, and the Centre for the Study of Platonism at the University of

Cambridge. He has authored two monographs in German and English, along with numerous articles and contributions to collective volumes. In April 2025 he was awarded the Academic Research Prize of the University of Athens. His teaching and research interests focus on the intersection of theology, philosophy, and science, with emphasis on philosophy of mind, ecology, new technologies, and human rights.



Dimitrios Keramidas. Lecturer at the Pontifical University of St. Thomas Aquinas (“Angelicum”), Rome. He was born in Thessaloniki. He studied Theology at Aristotle University of Thessaloniki (AUTH) and Missiology at the Pontifical Gregorian University in Rome. He teaches Ecumenical Movement and Orthodox Theology at the Pontifical University of St. Thomas Aquinas (“Angelicum”), Rome, and also collaborates with other universities in Italy. His research interests include contemporary Orthodox theology, Orthodox–Catholic dialogue, and the theology of mission. He is Co-chair of the Ecumenical Dialogue Group of the International Orthodox Theological Association (IOTA), a member of the Center of Ecumenical, Missiological and Environmental Studies “CEMES” in Thessaloniki, a member of Societas Oecumenica, and an associate of the Italian Ecumenical Association (AIDecu).

Archim. Jack Khalil. Dean of the St. John of Damascus Institute of Theology at the University of Balamand, Lebanon, and Professor of New Testament Studies. He holds a Ph.D. in Theology from the Aristotle University of Thessaloniki, as well as postgraduate degrees in Public Law and Political Science (M.Phil.) and in Legal Theory (LL.M.) with specialization in Constitutional History. He has served as visiting professor at numerous universities, including Athens, Thessaloniki, Cambridge (IOCS), Paris (Saint-Serge), and Eastern Finland. His research focuses primarily on the Pauline Epistles and the Johannine literature. He is the author of several books and numerous articles in international journals and collective volumes, and contributes regularly to conferences worldwide. He also serves on various academic and ecclesiastical committees, including the Faith and Order Commission of the World Council of Churches.

Athanasios Koliofoutis. PhD in Theology. He was born in Thessaloniki in 1972, where he lives and works. He studied Theology at the Faculty of Theology of the Aristotle University of Thessaloniki (AUTH), where he received his degree (1995), his Master’s in Pastoral Theology (2002), and his Doctorate (2012). At the same Faculty he also completed his postdoctoral research (2022). Since 2003 he has been teaching as a Theology educator in secondary education, while he has also taught at universities in Greece (AUTH., University of Piraeus) and abroad (Neapolis University Pafos, Theological School of Congo). His research focuses on issues of Applied Pastoral Theology in contem-



porary postmodern society, with numerous publications in reputable academic journals. He is a registered trainer of the Institute of Pastoral Training of the Archdiocese of Athens, with which he actively collaborates, having also authored related educational material for its training programs. In parallel with his educational duties, he also collaborates with the Institute of Educational Policy, participating in its scientific working groups.

Konstantinos Kotsiopoulos. Professor of Sociology of Christianity at the Department of Social Theology and Christian Culture of the Aristotle University of Thessaloniki. He serves as a member of the following Scientific Committees:

1. Academic Advisor of Hellenic National Academic Recognition and Information Center, 2. Evaluator of Teaching Staff Candidates at the Hellenic Open University, 3. Research Associate of the Laboratory of the Study of Religions at the Department of Social Theology and the Study of Religion of the National and Kapodistrian University of Athens, 6. Scientific–Academic Supervisor and Instructor of the Training Programs of the Lifelong Learning Center of the Aristotle University of Thessaloniki, 8. Member of the Foundation for Pastoral Education of the Church of Greece (Holy Archdiocese of Athens), 9. Former member of scientific and organizing committees of international and local conferences. He has authored numerous studies and articles published by reputable publishers and peer-reviewed journals. He has participated in many international conferences and workshops. He regularly contributes his scientific perspective to the media on contemporary social issues and their relation to Theology, Culture, and Europe.

Dimitra Koukoura. Emerita Prof. Dr Dimitra Koukoura was the first woman to be elected professor in the Department of Theology of Aristotle University of Thessaloniki, where she taught (1993-2020) Homiletics, Orthodox Witness, and Communication. She studied Classics, Linguistics and Byzantine History at AUTH and Sorbonne-Paris, and Theology at AUTH and the Catholic Institute of Paris (Patristics, Liturgics). She is the author of books and articles on the



evolution of preaching from the first to the second millennium, the effects of rhetorics on Christian homily, Orthodox witness in ecumenical dialogues, the need for evangelization in former Christian societies, and the role of women in the Orthodox Church. She has been involved in the ecumenical movement since 1986, representing the Ecumenical Patriarchate under various capacities in various meetings, consultations, conferences, in 5 Assemblies (1991-2022 -WCC); as a member of the Commission of Faith and Order, the Central Committee, and the Commission on Churches in Dialogue of the CEC. Additionally for a long time, she represented WCC at the Global Christian Forum. She is currently an academic advisor at “LOGOS” University College - Tirana of the Orthodox Autocephalous Church of Albania.

Georgios Kounnousies. Teaching staff at the Theological School of the Church of Cyprus and religious teacher in the secondary education. Graduate of the Dept. of Theology of the Aristotle University of Thessaloniki, where he continued his postgraduate studies (MA) in Sociology. He holds a PhD in Sociology from the same University. At the Theological School of the Church of Cyprus, he teaches the undergraduate course Sociology of Religion. At the same time, he works as a Theology Teacher in Secondary Education. For eight years (2015-2023) he taught the courses Sociology of Religion and Sociology of Christianity at the Priestly School “Apostolos Barnabas” of the Church of Cyprus. He also served as a Special Scientist at the University of Cyprus, Department of Education, teaching the course School Experience (academic years 2016–2019). He has published monographs and articles in academic journals, edited volumes and theological journals in Cyprus and Greece. He has also participated in conferences in Cyprus and abroad.

Georgios Kountouris. Professor at the Higher Ecclesiastical Academy of Athens, specializing in General Church History. He was born in Piraeus and holds degrees from the Higher Ecclesiastical School of Athens and the School of Theology of the National and Kapodistrian University of Athens (NKUA). He served as President of the Student Union and has received various scholarships. He has extensive teaching experience both in Greece and abroad (Charles University in Prague, University of Prešov, Higher Ecclesiastical Academy of Ioannina, Evangelical School of Nea Smyrni, Italian School of Athens, Higher Ecclesiastical School of Crete, among others). He has a significant record of translations from Slavic languages and has participated in numerous conferences as a speaker. He is the author of several scholarly works and publications. His most recent work is *A Historical Approach to the Institution of Episcopalis Audentia* (Athens: Grigoris 2024, in Greek). In parallel, he has been actively involved in ecclesiastical life, with participation in inter-Orthodox events, serving also as interpreter for various ecclesiastical, academic, and political delegations.



Alessandra Lemma. Fellow of the British Psychoanalytic Society and Chartered Clinical and Counselling Psychologist, is a Visiting Professor in the Psychoanalysis Unit, University College London and Consultant, Anna Freud Centre and Visiting Professor, Centro Winnicott, Rome. For 16 years she worked at the Tavistock Clinic where she was, at different stages, Head of Psychology and Professor of Psychological Therapies in conjunction with Essex University. She was a recipient of the 2022 Sigourney Award in recognition of her theoretical and clinical contributions to understanding body modification practices, the impacts of technology on psychic functioning and transgender identities as well as for her efforts in developing and disseminating worldwide a brief psychoanalytic intervention for mood disorders. She has published extensively on psychoanalysis, trauma, the body, transgender identities, and ethics. Her most recent book *First Principles: Applied Ethics for Psychoanalytic Practice* (OUP, 2023) was nominated for the Gradiva Award in the category: “Best Book 2024”.

Fr Nikolaos Loudovikos. Professor of Religious Studies and Hermeneutics of Religion at the University of Ioannina. He studied Psychology, Pedagogics, Theology and Philosophy in Athens, Thessaloniki, Paris and Cambridge. He was Professor of Dogmatics and Philosophy at the Higher Ecclesiastical Academy of Thessaloniki and of Athens, and is Visiting Professor at the University of Balamand and the Orthodox Institute of Cambridge. He has given lectures and seminars at more than 25 Universities around the world. He directs the English-language international academic journal *Analogia: the Pemptousia Journal for Theological Studies*. He has published 18 books and numerous articles, translated into 10 languages. His latest books in Greek: *Open History and Its Enemies: The Rise of Velven Totalitarianism* (2020), *Trasparent Harmony: A Metaphysical History of Ancient Greek Philosophy* (2021), *Rethinking Humanism* (2024), *The Techno-Ape and the Truth: A Hermeneutics of Religion in the Age of Artificial Intelligence* (2024), *Maximus the Confessor, Chapters on Love*, with an Introduction to the Work of the Confessor and Commentary (2024). In English: *Analogical Identities: the Creation of the Christian Self. Vol. I: Beyond Spirituality and Mysticism in the Patristic Era* (2019); *Vol. II: Intermeaningfulness: self-catholicization, Meta-narcissism, and Christian Theology* (forthcoming).

Anastasios G. Maras. PhD and Postdoctoral Researcher in Theology, with a degree in Library Science. He currently teaches at the Higher Ecclesiastical Academy of Athens and in the Postgraduate Program of Orthodox Theology at the Hellenic Open University. He has participated as a speaker in 43 conferences and is a member of the Editorial Board of the journals *Byzantinos Domos* and *Analekta of Humanistic Sciences*. His publications include 75 articles, 15 chapters in collective volumes, 49 entries in dictionaries and encyclopedias, 10 book reviews, and 2 translations, while he has also edited 10 collective volumes. His



main monographs (all in Greek) are: *Saint Patrick of Ireland: New Evidence on His Life and Works* (1993), *The Eschatology of Saint Gregory of Nyssa* (2002), *The Person of Christ in Philosophers and Apologists* (2003), *Religious Education, Grade I of Lyceum: Companion Book* (2004), *Church – Environment – Education* (2004) *Introduction to Informatics: Theology and Informatics* (2005), *The Views of the Greek Apologists and of Eusebius of Caesarea on Art* (2006), *Patristic Theology and Christian Culture* (2008), *The Greek Orthodox Church: From the Fall of Constantinople to the Present* (2012), *Contemporary Scientific Technography* (2014), *Saint Demetrios of Thessaloniki: The Life of the Saint and the History of His Church* (2019), *Theophilos of Antioch: To Autolykus* (2024).

Michalis Marioras. Professor of History of Religions at the Faculty of Theology, National and Kapodistrian University of Athens (NKUA). He was born in Athens in 1974 and completed his secondary education at the Ionideios Experimental School of Piraeus. He studied at the Faculty of Theology of NKUA and pursued further studies at the Universities of Fribourg and Geneva (Switzerland) and Marburg (Germany). Since 2008 he has served at the Faculty of Theology, NKUA, while he has also taught in the Postgraduate Program “International Medicine – Health Crisis Management” of the Medical School of NKUA, in other inter-university and interdepartmental postgraduate programs, at the Institute of Pastoral Training of the Archdiocese of Athens, and at the Hellenic Air Force Academy of Administration and Staff Officers. From 2009 to 2011 he served as Special Advisor to the Ministry of Education and Religious Affairs on matters of his expertise. In 2012 he was an official guest of the United States Department of State in the International Visitor Leadership Program on “Integration of Migrant Muslim Youth for Greece: Challenges and Prospects.” His published books include (all in Greek): *Islam from the Balkans to Europe(?): The Question of Islamic European Identity*; *Islamic Radicalism: Historical and Theological Preconditions of Jihad*; *Islam: Seeking Ways with Muslims*; *The Pre-Islamic Religions of the Arabian Peninsula: The Expected and the Unexpected*; *The Dialogue between Western and Muslim Scholarship on Sharīʿa* (vols. I-II). He also contributes regularly to the daily press.

Protopr. Sergios G. Marnellos. Assistant Professor of Canon and Ecclesiastical Law at the Department of Theology, School of Theology, Aristotle University of Thessaloniki. He was born in Agios Nikolaos, Crete. He received his degree in Theology from the School of Theology of the National and Kapodistrian University of Athens (1998), and subsequently a Master’s degree in Ecumenical Theology (2004) from the Department of Theology, School of Theology, ATh. He then pursued doctoral studies at the Institut de Théologie Orthodoxe Saint-Serge in Paris, where he was awarded a PhD in Orthodox Theology (2006), while also attending the Pan-European Inter-University Doctoral



Program “Socrates-Gratianus” with specialization in European Comparative Ecclesiastical Law. He has taught by assignment at the Patriarchal Higher Ecclesiastical Academy of Crete, served as a permanent Professor in Secondary Ecclesiastical Education, and by secondment at the Higher Ecclesiastical Academy of Vellas in Ioannina. In 2018 he was transferred to the same Academy as a member of the Special Teaching Staff (EDIP), specializing in Canon Law. In 2021 he was elected Assistant Professor of “Canon Law and Pastoral Theology of the Church” at the Higher Ecclesiastical Academy of Vellas, Ioannina, and subsequently also served at the Higher Ecclesiastical Academy of Athens. In February 2024 he was elected to the School of Theology of AUTH.

Fr Philotheos-Photios Maroudas. Appointed Lecturer in Postgraduate Programs at the School of Philosophy, University of Athens. He serves within the jurisdiction of the Ecumenical Patriarchate as a clergyman of the Holy Metropolis of Germany. He is Head of the 2nd Greek Section of the International Chair in Bioethics (ICB), holds a PhD in Ecclesiology from the University of Strasbourg, and is a PhD candidate in Religious Studies at Aristotle University of Thessaloniki. He is actively involved in inter-denominational, interfaith, and academic initiatives aimed at fostering the creative coexistence of diverse traditions and philosophies. His scholarly activity focuses on Systematic Theology in Christianity and Islam, with particular emphasis on the field of Global Ethics and the exploration of intercultural reality in the contemporary world. He expresses this engagement through the organization of and active participation in conferences of related themes, as well as through publications in academic journals and collective volumes.

Gjergji Mulla. Associate Professor of Department of Statistics and Applied Informatics (since 2014), Vice Dean of the Faculty of Economics, University of Tirana. From 2002 to 2013, he served as an external teaching associate at the Department of Informatics of the Faculty of Natural Sciences. Between 2000 and 2014, he held various positions in the IT departments of second-level banks and also served as Chief Information Security Officer at Credit Agricole Bank (Albania). He completed his studies in Informatics at the Faculty of Natural Sciences in 2002 and, in 2007, obtained a second-level Master’s degree in Informatics at the same Faculty. In 2016, he earned his PhD with a dissertation on “The Construction of a Security Plan for the Protection of Critical or Sensitive Processes and Information”. He has been engaged in teaching since 2002, mainly in courses related to Information Security and Computer Application Development. He has made significant contributions to the field of research, as evidenced by his works, scientific articles, publications, and participation in conferences. In addition, he has extensive experience in the development and implementation of information systems.



Efthymios Nikolaïdis. Emeritus Director of Research at the Institute of Historical Research of the National Hellenic Research Foundation. He studied Physics (Maîtrise, Paris XI) and History of Science (DEA and PhD, École des Hautes Études en Sciences Sociales, Paris). His academic career at the NHRF began in 1987; he was elected Director of Research in 2001 and Emeritus in 2022. His research focuses on the history of the relationship between religion and science, the history of science in the Greek world from Byzantium to modern Greece, the transmission of classical science (17th-19th c.), and the history of scientific policy and astronomy. He has led major international projects such as HEPHAESTUS, NARSES, and Science and Orthodoxy around the World. His publications include numerous monographs and edited volumes, among them *Science and Eastern Orthodoxy* (Johns Hopkins University Press 2011; in French, Éditions Garnier 2018) and *Greek Alchemy from Late Antiquity to Early Modernity* (Brepols 2018), and articles in leading international journals. He served as President of the International Union of History and Philosophy of Science / Division of History of Science and Technology (2013-2017) and is Permanent Secretary of the International Academy of History of Science. He is co-editor of *Almagest: International Journal for the History of Scientific Ideas* and sits on the editorial boards of several leading journals. His international presence includes lectures, conferences, and collaborations across Europe, the Americas, and Asia, making a significant contribution to the study of the history of science and the dialogue between science and Orthodoxy.

Ioannis Panayiotopoulos. Professor at the Department of Theology, School of Theology, National and Kapodistrian University of Athens (NKUA). He graduated from the Department of Theology of NKUA (1993), specializing in General Church History. He received postgraduate degrees from the University of Durham (1997) and NKUA (1998), and a PhD from NKUA (2002). He worked in Secondary Education (1999-2010). He served as Special Advisor at the General Secretariat of Information (2004-2007) and as Secretary General for Media (2012-2014). He has an extensive teaching and publishing record, writes regularly in journals, and maintains an active academic, political, and social presence.

Petros Panayiotopoulos. Associate Professor at the Department of Theology, Faculty of Theology, Aristotle University of Thessaloniki (AUTH). He studied Physics and Theology at AUTH and was a member of the writing team for the Pastoral Theology textbook for the third grade of Ecclesiastical High Schools, as well as for the study materials of the “Exomologetics” Program of the Institute of Pastoral Training of the Archdiocese of Athens. He currently serves as Vice-Chair of the Department of Theology at AUTH, teaches at the Faculty of Theology of the Orthodox University of Congo, is a member of the Metropolitan Council



of the Metropolis of Neapolis and Stavroupolis, and President of the Board of the Association of Theologians “Kairos – For the Advancement of Religious Education”. His teaching includes courses on Ethics, Pastoral Theology, Bioethics, the relationship between Religion and Science, and Missiology. His published books (in Greek) include: *Divisions and Incompatibilities: Natural Sciences and Theology* (2019) and *Quality of Life: Request–Ambiguity–Measurement* (2022).

H.E. Panteleimon, Metropolitan of Maroneia and Komotini. Born Stavros Moutafis in Kavala in 1970. He studied at the Higher Ecclesiastical Academy of Athens and at the Faculty of Theology of the Aristotle University of Thessaloniki. He pursued postgraduate studies at the Faculty of Theology of the National and Kapodistrian University of Athens, where he received an MA in Dogmatic Theology with a thesis on “The Views of Eustratius of Nicaea on Icons.” He holds a PhD from the Department of History and Ethnology of the Democritus University of Thrace. Ordained Deacon and Presbyter in 1996, he served as Protosyncellus of the Metropolis of Xanthi and Peritheorion (1996-2013) and as Abbot of the Monastery of Panagia Archangeliotissa in Xanthi. He has authored studies in monographs and collective volumes. On 24 February 2013 he was consecrated Metropolitan of Maroneia and Komotini.

Niki Papageorgiou. Professor of Sociology of Religion and Ethics at the Department of Theology, Aristotle University of Thessaloniki. She studied Theology at AUTH and Sociology of Religion at the Catholic University of Louvain-La-Neuve (Belgium). At AUTH she teaches the compulsory courses Sociology of Religion and Sociology of Christianity, as well as Religions and Societies in the Middle East in the introductory track of Islamic Studies. She also offers elective courses in the undergraduate program of the Department of Theology: Religion, Identity and Politics and Gender, Religion, Politics. She further teaches in the postgraduate programs Theology and Culture and Religion, Geopolitics and International Security of the Department of Theology, AUTH, as well as in the interdepartmental programs Tourism and Local Development and Contemporary Medical Practices: Legal Regulation and Bioethical Dimension. She is the author of the books: *The Church in Modern Greek Society: A Sociolinguistic Analysis of the Encyclicals of the Holy Synod* (2000, in Greek); *Transformations of the Sacred: Sociology and Religion in the Work of Marcel Mauss* (2005, in Greek); *Religion and Migration: The Sikh Community in Greece* (2011, in Greek); *Religion in the Metapolitefsi: Boundaries and Ambiguities* (2018, in Greek); *Society, Religion and Law: Overlapping Relations and Intersections* (with Prof. Konstantinos Papageorgiou, AUTH Law School) (2020, in Greek). She has also published numerous articles in academic journals and collective volumes on topics within her field of expertise.



Vesselin Petkov. Professor of Theoretical Physics & Philosophy, one of the Founders and current Director of Institute for Foundational Studies “Hermann Minkowski”, Montreal, Canada. Informally associated with the Department of Philosophy of Science of the Institute of Philosophy and Sociology at the Bulgarian Academy of Sciences. Education: PhD in Theoretical Physics (1997, Concordia University, Montreal); PhD in Philosophy (1988, Bulgarian Academy of Sciences); MSc in Physics (1980, University of Sofia). Employment: Since 12 October 2011 - One of the founding members and current director of Minkowski Institute in Montreal (<https://minkowskiinstitute.com>); April 2000 - April 2011 - Teaching at Concordia University in Montreal; April 1986 - May 1989 - Research at the Institute for Philosophical Research, Bulgarian Academy of Sciences and part-time teaching at the University of Sofia; January 1982 - March 1986 - Research (Mossbauer Spectroscopy) at the Department of Atomic Physics of the University of Sofia.

Aleksandar Petrović. Full Professor at Seminar for Humanities, Faculty of Philology, University of Belgrade, where he teaches Theory of Culture and Civilization, Cultural Anthropology, Ethics, Cultural Diplomacy. He is President of the PhD Department for History and Philosophy of Science and Technology, University of Belgrade where he teaches History of Science, Theory of Knowledge, History of Climate Change. He is the author of nine monographs and more than two hundred articles in scientific journals worldwide. He is a member of Editorial Boards of scientific journals: *Almagest*, International Journal for the History of Scientific Ideas, Belgium; *People Say*, Toronto, Canada; *Annales Universitatis Paedagogicae Cracoviensis*, Cracow, Poland; *Modern Research Studies*, India; *Newsletter for the History of Science in Southeastern Europe*, Athens. He is editor and author of the book *Orthodoxy and Artificial Intelligence*, the first publication in this field, published in 2019 by National Hellenic Research Foundation. Advisor of the international scientific project “Science and Orthodoxy around the World” led by National Hellenic Research Foundation and Templeton Foundation. Member of the Scientific Committee - International Conference [PHAICON24] of the Posthumanism and Artificial Intelligence, co-organised by Saint Maxim the Greek Institute and the Office of the Orthodox Church at the European Union. Invited lecturer on subject “Artificial Intelligence and Theology” at the St John of Damascus Institute of Theology University of Balamand, Lebanon, under High Patronage of John X, Patriarch of Antioch. President of the Scientific Committee of the conference “Technology, Religion and Cultural Identity: An Exploration from Comparative Multi-Polar Perspective” at University of Madras. He is a corresponding member of the Académie internationale d’histoire des sciences (Paris), president of Serbian Society of History of Science, Secretary of the Board for Climate Dynamics of the Serbian Academy



of Science and Arts, President of the National Jury for the Creativity Award in Humanities of the World Intellectual Property Organization, Genève.

Konstantinos Petsios. Professor of History of Philosophy at the School of Philosophy of the University of Ioannina and Director at the Research Laboratory of Modern Greek Philosophy. He is the scientific director of the Journal of the Research Laboratory of Modern Greek Philosophy, *Mirror of Modern Greek Philosophy*, which publishes studies, after a “blind review”, that deal with the manuscript philosophical tradition of Modern Greek Philosophy. He served as President of the Hellenic Philosophical Society (2017-2019), as a long-time member of the Senate of the University of Ioannina, and as Chair of the Department of Philosophy, Education, and Psychology (2011-2013, 2013-2015), as well as of the Inter-Institutional and Interdepartmental Postgraduate Program “Greek Philosophy - Philosophy of the Sciences” (2014-2016, 2016-2018). He is a member of the Hellenic Philosophical Society, the Research Group on Modern Greek Enlightenment, and the Society for Epirote Studies (E.H.M.), of which he is also a board member. He currently serves as President of the Institute for Ionian and Adriatic Studies. He was a member of the Review Committee for the 23rd World Congress of Philosophy (WCP 2013, Athens), responsible for the evaluation and chairing of sessions across 75 thematic sections for contributed papers, following nomination by the International Committee of FISP. He has participated in numerous national and international academic conferences and has published 17 books and a large number of articles on various aspects of Ancient Greek, European, and Modern Greek philosophy.

Aleksandar Spasenovski. Full Professor of Constitutional Law and Political System at the Faculty of Law “Iustinianus Primus”, Ss. Cyril and Methodius University in Skopje. He holds a Master’s degree in international relations and earned his PhD with a dissertation on the constitutional and legal status of religions and the protection of freedom of religion. He is the author of several university textbooks, including: *Political System*; *Political Parties and Interest Groups*; *Local Self-Government*; *Parliamentary Law*; *Law and Religion*; *Constitutional Procedural Law*. His academic interests include the relationship between state and religion, constitutional identity, and the institutional design of democratic systems. He has taken part in the drafting of key legislative reforms and has lectured at various academic institutions in the region on topics related to political systems, religious freedom, and democratic governance. He served as a Member of Parliament for three terms and regularly participates in academic forums in the field of law and political science.

Vasiliki Stathokosta. Professor at the National and Kapodistrian University of Athens. She was born in Lamia and studied Theology at the Aristotle Uni-



versity of Thessaloniki. She pursued postgraduate studies at the Faculty of Theology of AUTH, at the Ecumenical Institute of Bossey/Geneva, and at the Faculty of Theology of the University of Fribourg, with scholarships from the Ecumenical Patriarchate, the World Council of Churches, the Roman Catholic Church, and the Greek State Scholarships Foundation (IKY). She was awarded a PhD in Theology from NKUA (2000, with distinction) and carried out postdoctoral research on the Ecumenical Movement (IKY, 2002-2003). She has worked in research projects on the Orthodox Church in the modern world, the Ecumenical Movement, religious freedom, gender, and multiculturalism, and has represented the Church of Greece at international ecumenical conferences, including the Plenary of the Faith and Order Commission of the WCC (Crete, 2009). She served as a secondary school teacher of theology (2001-2009) and since 2009 has been teaching at the Faculty of Theology, NKUA. She has published studies on the Orthodox Church and ecumenism, religious freedom, evangelism, and the role of women in the Church.

Marina Stojanovic. PhD in Patristics, from the Faculty of Orthodox Theology in Belgrade, with a dissertation entitled “Being and Interpretation. The Exegesis of Origen and its Ontological Postulations.” She teaches Religion at the Gymnasium of Smederevo and also serves as an official in the Diocese of Braničevo. She has published around a dozen research papers, primarily in the field of Patristics, as well as translations of theological texts.

Mariyan Stoyadinov. Associate Professor of Dogmatic Theology in the Faculty of Orthodox Theology at the Veliko Tarnovo University “St Cyril and Methodius”. He graduated from the Faculty of Theology at Sofia University “St. Clement of Ochrid” and holds a PhD in Dogmatics from the same University. He has been member of the Union of Scientists in Bulgaria and the International Association of Orthodox Dogmatic Theologians. He has also been Visiting Professor in the Faculty of Theology in Alba Iulia (Romania). His research interests focus on Systematic Theology, History of Dogma and Theology of Icon.

Konstantinos Tambakis. Senior Researcher at the Institute of Historical Research of the National Hellenic Research Foundation (NHRF), where he coordinates the History of Science and Technology Program. He studied Physics (BSc, NKUA), earned an M.Ed. in Science Education (NKUA), and received his PhD in History of Science from the University of Athens, with a dissertation on the training of science teachers in Greece (1831-1950). He has held research and teaching positions at the University of Cambridge (Visiting Scholar, Research Associate, 2009-2010), Princeton University (Ted and Elaine Athanassiades Postdoctoral Research Associate, 2011-2012), and the Hellenic Open University (since 2009). His research focuses on the intellectual and cultural history



of science in the Greek-speaking world (18th-20th century), the interactions between Orthodox Christianity and science, and the relationship between science and literature. He has coordinated or participated in major international projects funded by the Templeton Foundation and the Hellenic Foundation for Research and Innovation, including Science and Orthodoxy around the World, Atheism, Hellenic Orthodoxy and Science in Greece (1935-1974), and Science, Religion and Atheism: A series of spring schools. His publications include articles in *Isis*, *Zygon*, *History of Science*, and the *British Journal for the History of Science*. He has also co-edited volumes such as *History of Science and Orthodox Christianity* (2024) and *Science, Religion and Nationalism: Local Interactions and Global Historiographies* (2024).

Nikolaos F. Tompros (Patras, 1968). Associate Professor of Political History at the Hellenic Army Academy and Director of the Historical Archive of the Church of Greece. He graduated in 1992 from the Department of History of the Ionian University, where in 2001 he defended his doctoral dissertation in Modern Greek History. He has taught various undergraduate and postgraduate courses at the University of the Peloponnese (2004-2010), the University of Ioannina [Agrinio] (2007-2009), the Hellenic Open University (2017-2019), as well as at the Ionian University (2004-2012). He has participated in research projects at the General State Archives of the Prefecture of Achaia and the Army History Directorate. His major works include: *From Neohellenism to the Independent Greek State (1453-1832)* (2013), *Monasticism in the Newly Established Greek State (1833-1862)*, vols. I–II (2019), *The City of Welfare and the Municipality of Patras (1835-1922)* (2019), *Patras in the Greek Revolution (1821-1828). Historiography and Public Discourse* (2020). He has participated in numerous international and national scientific conferences and has published extensively in peer-reviewed Greek and international journals. His research interests focus on the Greek Revolution and on political and social Greek history of the 19th century and the first decades of the 20th century.

Vasileios Tsingos. Professor at the Department of Social Theology and Christian Culture, Aristotle University of Thessaloniki. He was born in Agrinio and studied Theology at the Faculties of Theology of AUTH and the Roman Catholic University of Dublin. Since 2000, he has been teaching Dogmatics of the Orthodox Church. His research interest focuses on the authentic presentation of the content of the Orthodox faith, both diachronically and synchronically, in relation to the way of life of the ecclesial community. He has participated in dozens of theological conferences, symposia, and colloquia in Greece and abroad, and has delivered numerous lectures on theological issues, contemporary concerns, and current affairs. He served as Visiting Professor at the St. John of Damascus



Theological Institute of Balamand University, Lebanon (2014–2020). He has published 14 monographs and 67 articles in Greek and international journals. Selected works: *Ecclesiological Positions of St. Theodore the Studite: Authority and Primacy* (1999, in Greek); *The Renewal of Man according to the Dogmatic Teaching of St. Symeon the New Theologian* (2009, in Greek); *Prolegomena to the Theological Epistemology of St. Gregory Palamas* (2010, in Greek); *Charisma and Institution in the Ecclesiological Teaching of St. John Chrysostom* (2016, in Greek); *Man, the Great in Little: Aspects of Orthodox Anthropology* (2019, in Greek); *Dogmatics of the Orthodox Church* (2022, in Greek); *Perichoresis: Theological Content of the Term and its Applications* (2023); *Dogmatica della Chiesa Ortodossa*, vol. I (2024), vol. II (2025).

Christos Tsironis. Professor at the Department of Theology, Aristotle University of Thessaloniki, where he teaches Contemporary Social Theory, Sociology of Education, Sociology of Christianity, Sociology of Tourism, Epistemology of Otherness, among others. He received extensive training as a youth educator within the educational programs of the Council of Europe and contributed to the authorship and editing of training manuals focusing on intercultural communication, Human Rights education, and the prevention of human trafficking. He has authored articles on social theory, theology, sociology of education, epistemology, and research. He has worked as a trainer and social researcher in national and international research and training projects. He has also served as a student counselor and organized social support programs in prisons, schools in underprivileged areas, and youth centers. Moreover, he has participated in various social programs as an army sociologist, professional, or scientific coordinator for combating social exclusion, child trafficking, and in the training of educators and social service professionals. He has taken part in numerous national and international academic conferences and published scholarly articles in collective works, both in Greek and foreign-language editions. His research interests focus on issues of Social Theory, Social Ethics, Theology, Education, and the Welfare State.

Şeref Halil Turan. Professor of Philosophy at the Middle East Technical University (METU), Ankara, where he has served since 2014 and was appointed full Professor in 2018. His research interests cover ethics and aesthetics, philosophy of art and music, political philosophy, and the history of philosophy from antiquity to modernity. He has supervised numerous doctoral and postgraduate theses on Plato, Aristotle, Nietzsche, Wittgenstein, Bakhtin, Rousseau, Kant, Hobbes, and others. He is the editor of *New Perspectives on India and Turkey: Connections and Debates* (2018) and author of several book chapters and articles. He has coordinated and participated in funded projects, including an Eras-



mus+ program on Innovative Ethics Education (2022-2025). He is a member of the Turkish Philosophical Society and the Applied Ethics Research Center at METU, and has been involved in organizing national and international congresses on philosophy and ethics.

Archim. Chrysostomos-Gregorios Typmas. Physician and priest at the Church of Saint John Chrysostom, located within the American Farm School in the Metropolis of Thessaloniki. He has also served for several years in the Archdiocese of Thyateira and Great Britain. He graduated from the School of Medicine of the Aristotle University of Thessaloniki (AUTH) and completed his PhD at the Centre for Psychoanalytic Studies at the University of Essex, UK. His doctoral dissertation focused on a comparative study between psychological development and individuation in the Analytical Psychology of Carl Jung and spiritual advancement toward deification (θέωση) in the theology of Maximus the Confessor. He also conducted postdoctoral research in the Department of Ethics and Sociology of the Faculty of Theology at AUTH, which was published under the title *Rous Autognosias* (Athens: Armos 2018). He has been invited as a visiting lecturer at the Universities of Essex (UK), Helsinki, Tartu (Estonia), Athens, and Thessaloniki, teaching on the relationship between Theology and Psychology, as well as in the field of Pastoral Psychology. He currently teaches “Archetype Theory and Group Dynamics” in the Interdepartmental Postgraduate Program of the National and Kapodistrian University of Athens entitled “Social Neuroscience, Social Pedagogy, and Education.” He is a member of various medical and academic associations and served as a member of the Committee of the Pastoral Care Network of the Ecumenical Patriarchate. He also participated in the recent research program of the National Hellenic Research Foundation entitled “Orthodox Theology and Psychoanalysis.”

Aristotle Typmas. Professor of History of Technology in Modern Times at the Department of History and Philosophy of Science of the School of Sciences at the National and Kapodistrian University of Athens. He has combined studies in Chemical Engineering (Msc, Aristotle University of Thessaloniki, 1989), Technology & Science Policy (MSc, Georgia Tech, 1995) and History & Sociology of Technology (PhD, Georgia Tech, 2001). Director of the English-language Interdepartmental Programme of Studies “Science, Technology, Society-Science and Technology Studies” at the University of Athens and Vice President for Research of the European Inter-University Association on Society, Science and Technology (ESST), he has, among other things, served as Chair of the Management Committee of “Tensions of Europe: Research Network on History, Technology and Europe” and as Chairman of the Scientific Council of the National Documentation Centre. Associate faculty member of the Institute for Mediterranean Studies of the Foundation for Research and Technology-Hellas

and the European University Viadrina, he was a visiting researcher at the MIT Program in Science, Technology and Society and at the Center of Research Excellence “Swedish Institute for Disability Research”.



Panayiotis Tzoumerkas. Associate Professor of Church History and Contemporary Life of the Modern Orthodox Churches at the Department of Social Theology and Christian Culture, Faculty of Theology, Aristotle University of Thessaloniki. He has published 16 monographs on the Ecclesiastical History of the Orthodox Church and the Ancient Oriental Churches, as well as 70 articles in peer-reviewed Greek and international journals and conference volumes. His studies have been published not only in Greek but also in English, Romanian, Serbian, and Arabic. He has participated in 35 international conferences and serves as reviewer and scientific editor for 11 academic journals and collective volumes. At the same time, he is a member of the Patriarchal Committees of the Patriarchate of Alexandria and All Africa on European Affairs, Inter-Orthodox and Inter-Christian Relations, and the Dialogue with the World Council of Churches. In addition, by joint decision of the Ministers of Foreign Affairs and Education, he was appointed President of the Supervisory Board of the Institute for Byzantine and Post-Byzantine Studies in Venice.

Evangelos Venizelos. Professor Emeritus at Aristotle University of Thessaloniki (AUTH) and a political figure of post-dictatorial Greece. He was born in Thessaloniki in 1957. He studied at the Faculty of Law of AUTH and pursued postgraduate studies at the University of Paris II. He was awarded a PhD in Law at the Faculty of Law of AUTH, where he was successively elected Lecturer, Associate Professor, and then Full Professor of Constitutional Law. At the same time, he practiced law before the Council of State, the Supreme Civil and Criminal Court of Greece, and the Supreme Special Court. He has published a large number of studies, monographs, case commentaries, and academic textbooks, as well as articles, essays, and books on a wide range of issues, including foreign policy, fiscal policy, European integration, and development policies. Since 1993, when he was first elected Member of Parliament with PASOK, he has served in various ministerial posts (Ministries of Press and Mass Media, Transport and Communications, Justice, Development, Culture, National Defence, Finance, among others), and has also held the offices of Deputy Prime Minister and President of PASOK.
